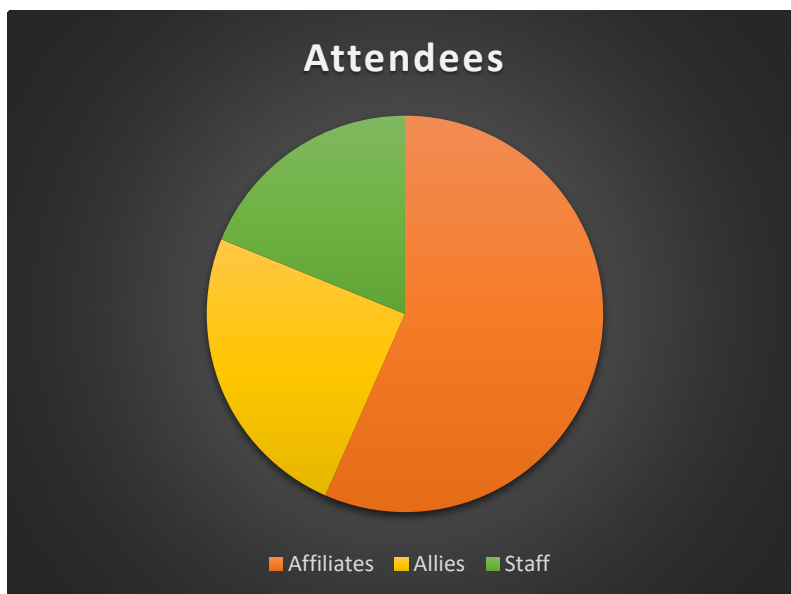


STATISTICS & EVALUATION SURVEY RESULTS

STATISTICS

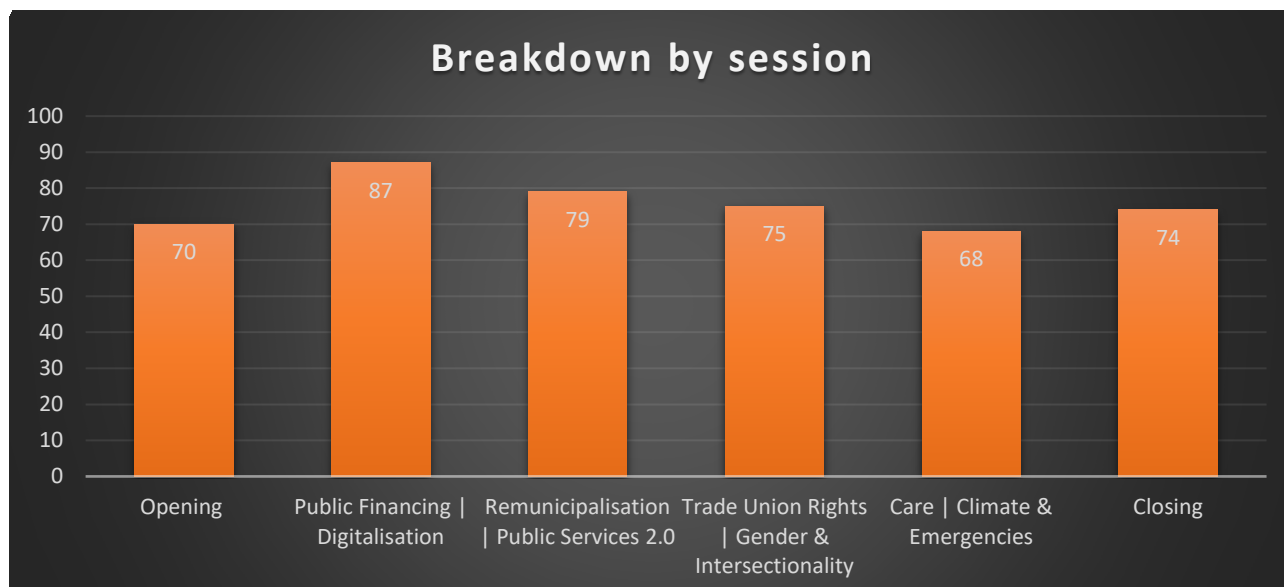
Attendees

228 people attended one or more sessions of the series bringing the total participation up to 453 people. Participants included **129** people representing **98** PSI affiliated unions, **43** staff members and **56** attendees from civil society and other organisations.



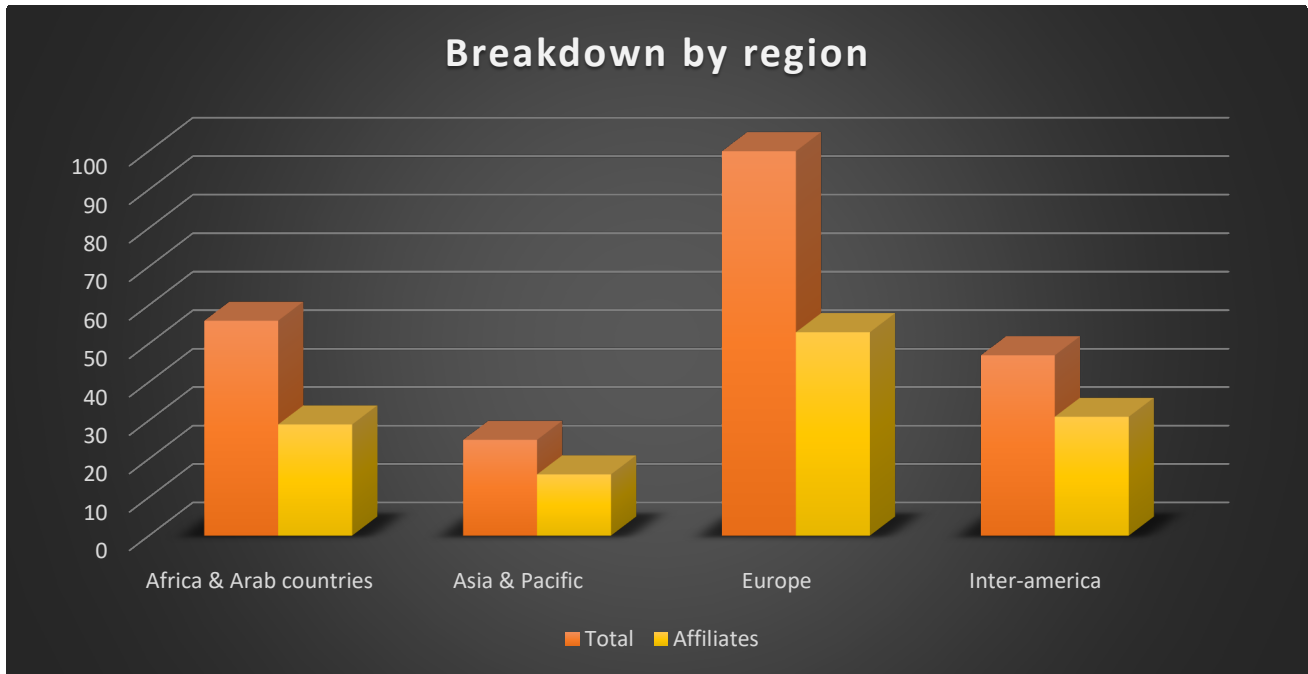
By session

There was on average **75** attendees by session. With a higher participation at the first session on public financing and digitalisation.

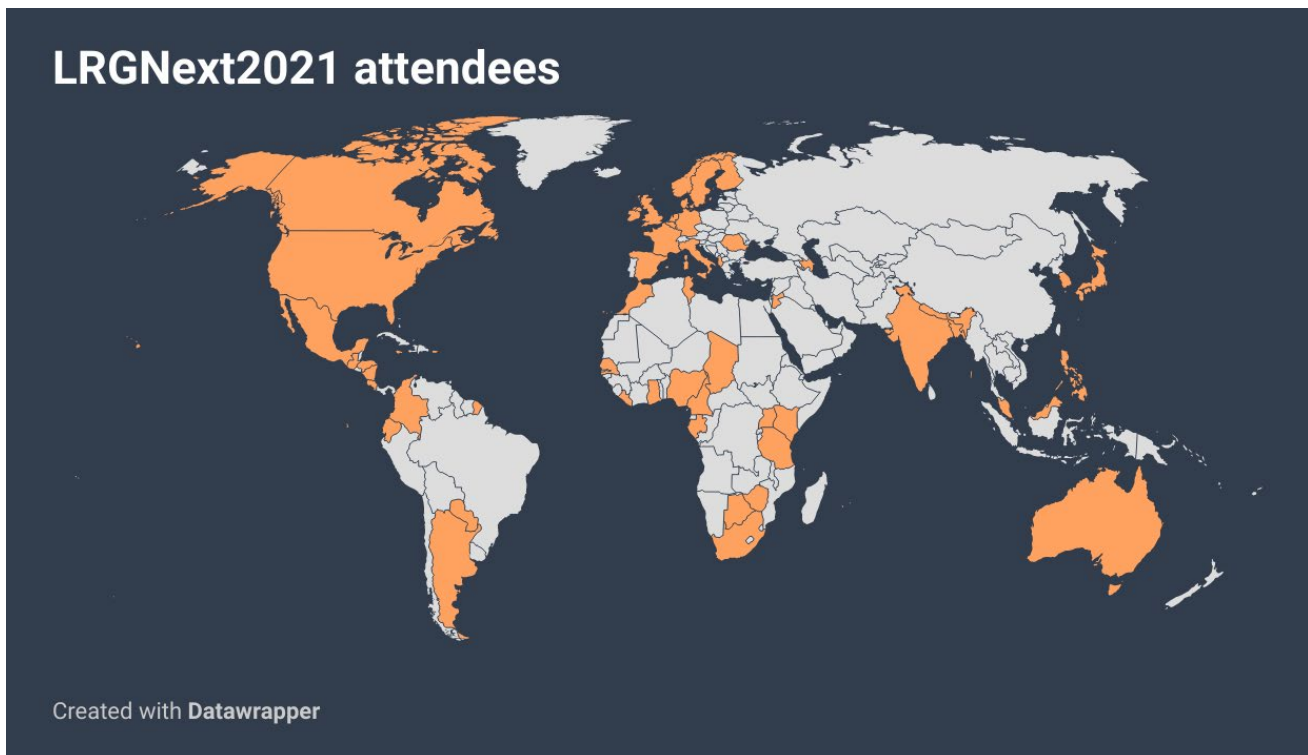


Regional breakdown

Africa & Arab countries: 56 (29 affiliates) – Asia & the Pacific: 25 (16 affiliates) – Europe: 100 (53 affiliates) – Interamericas: 47 (31 affiliates).



Representatives of PSI affiliates from 55 countries from all regions attended.



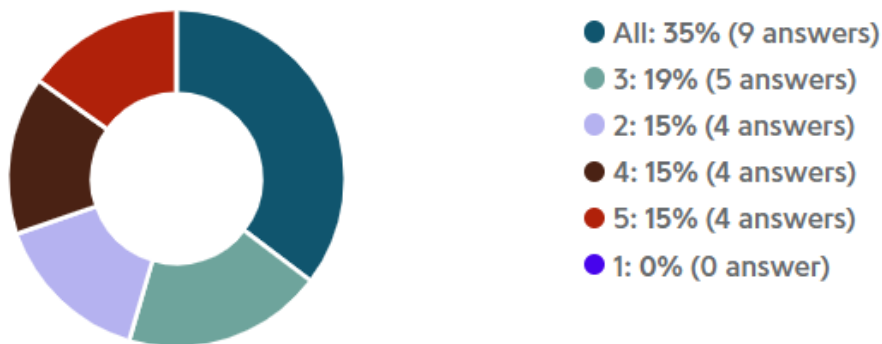
EVALUATION

How many sessions did you attend?

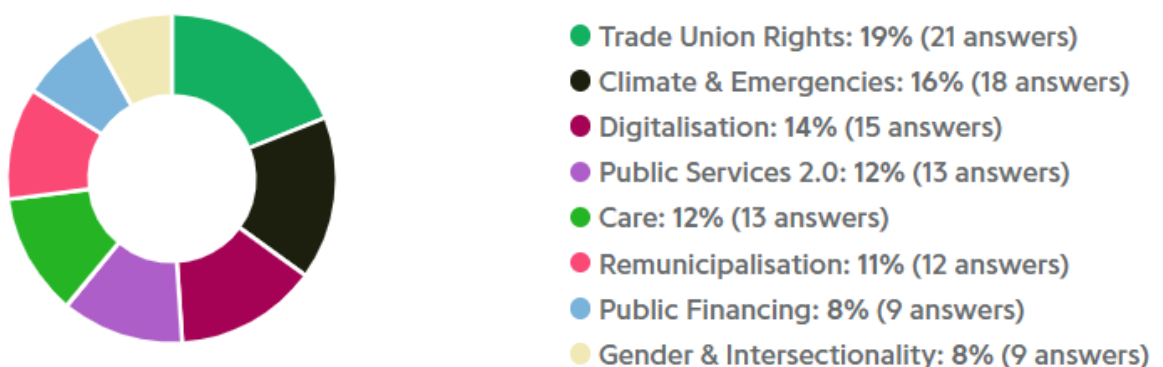
A majority of respondents had attended all six sessions (35%).

Most respondents identify **trade union rights** as the top theme relevant to their work followed by **climate & emergencies**.

Background briefs were produced for each session as well as a list of additional resources and other documentation. Are these materials useful and relevant to your work?



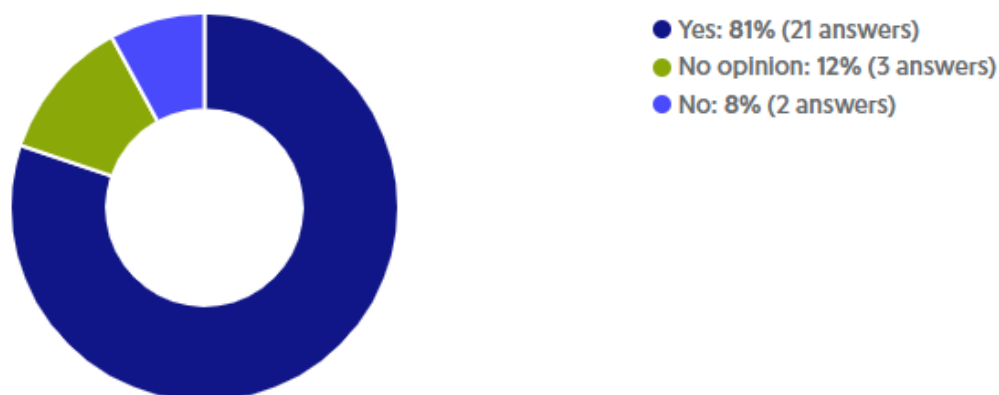
- Yes (please explain below): 68% (17 answers)
