If by any chance your country does not have a Chilean consulate or you are in a different place than your own country and you are required to travel for the in-person interview, we can support you.

If this is your case, when the consulate contacts you to schedule your interview appointment, please kindly reply asking them to authorize your online interview. In this reply, please copy GI-ESCR's Chile Representative Valentina Contreras (valentina@gi-escr.org) so she can keep track of your request and push for the online interview with the consulate and the Ministry of Foreign Affairs.

Be aware that in addition to the previous documents, you may require the presentation of a criminal record certificate, both from your country of origin and residence.

Prior to granting the visa, you must present an exit ticket that allows you to leave Chile, to your country of origin or residence, with verifiable data on the website of the corresponding airline, cruise ship or land company.

Finally, the visa will be granted, upon payment of the corresponding fee, by issuing an e-visa, which you will receive in the email account used in the SAC form, or by stamping the passport that must be managed in the respective consular

office.
